Eastern Oregon University (EOU)	<p><b>Programs excluded from the staff fee privilege at EOU:</b> EOU excludes all courses offered online, all onsite courses conducted at locations other than on the La Grande campus, and all courses offered as a part of summer term. Exceptions may be granted by the Dean of the College through which the specific course is offered.</p>
Oregon Institute of Technology (OIT)	<p><b>Programs excluded from the staff fee privilege at OIT:</b></p> <ol style="list-style-type: none"> <li>1. High School Transition Program</li> <li>2. Law--Appropriate Dispute Resolution</li> <li>3. Law--Environmental and Natural Resources</li> <li>4. Portland Program – Strategic Communication Masters</li> </ol>
