PEBB \$100 Member Vaccination Incentive

- Available to employees enrolled in a PEBB medical plan, opt out or declined coverage
- Not available to spouse/partner or other dependents
- Login to <u>PEBB account</u>
 - Complete COVID-19 Incentive Form
- Select vaccination status
 - Medical or religious exemption
 - Vaccinated
- Deadline to file, July 31, 2021
- Incentive included in August or September paycheck
 - Subject to State and Federal taxes

Faculty & OA Vacation Cap

- Faculty and OA increased cap ends on September 30th.
- Anyone with a vacation balance above the normal balance of 260 should use this extra vacation by the end of September.
- The vacation cap will be reverting to 260 hours effective October 1 and you will not be able to accrue vacation above 260 hours after that.



Faculty & OA Vacation Cap

- Vacation use in September will be deducted from your balance during October payroll and prior to any adjustments made to individual balances.
- Individual employee vacation balances over 260 will not be adjusted down to 260 until after the October payroll runs.
