10	University, the Union may authorize the University to deduct regular dues once per
11	month from the paycheck of Union members. The amount to be deducted will be certified by the

14	An authorization to deduct dues shall remain valid until written notice of cancellation is provided
15	to the University by the Union or until the employee is no longer a bargaining unit member,
16	whichever occurs first. The Union shall promptly forward to the University notice of
17	cancellations of a dues deduction authorization. Cancellation notices given by the member
18	directly to the University are invalid unless the member has ceased to be a bargaining unit
