Senior Law Service is a program of legal aid. It provides civil (not criminal) legal services to people age 60 and over who live in Lane County.

It focuses on serving those in the greatest economic or social need. A free consultation is provided.

Additional pro bono work may also be provided, depending upon the case details.

Please schedule an appointment by calling one of the centers listed on the back of this brochure. A volunteer attorney is on duty at the senior centers.

Before you see the attorney, a volunteer will ask for a limited amount of information.

The attorney may provide advice only or additional services. This depends upon the type of legal problem, the attorney's expertise in that area of the law, the attorney's ability to assist further, and the program's ability to assist further. We have a staff attorney for some types of cases.

If you do not get the help you need, please be sure to call the Program Director at 541-485-1017.

Pamphlets and self-help materials are available. Be sure to ask about them.

### Who is my attorney?

When you see an attorney at the senior center, that person is your attorney. The attorney on duty may limit the services that you receive. The attorney may provide advice only or additional services that you agree upon.

The Senior Law Service program itself will not be acting as your attorney (unless your case has been assigned to the staff attorney). If you have questions about your case, please talk directly with the attorney you meet at the senior center.

### Confidentiality

Senior Law Service will obtain some initial information from you before you see the attorney. This information will be shared with the volunteer attorney only. After you meet with the volunteer attorney, a limited amount of information will be provided to Senior Law Service. The information exchanged will remain confidential.
