

1 **ARTICLE 30. BENEFITS FOR ELIGIBLE RETIRED BARGAINING UNIT**
2 **FACULTY**

3
4 **Eligibility.** Bargaining unit faculty members who have at least five years of service at the
5 University of Oregon and who have retired from university employment (as defined in
6 Article 15, Academic Classification and Rank) are eligible for the following:

8 (a) Post-retirement appointments outside of the Tenure Reduction Program (TRP). The
9 University may offer an appointment to a retired bargaining unit faculty member for
10 other than TRP assignments. The Provost or designee will determine the salary to
11 be paid for such appointments, in accordance with the provisions of this Agreement.
12 The University is not required to hire the retired bargaining unit faculty member at
13 the same salary rate as his or her TRP rate.

15 The retired bargaining unit faculty member is solely responsible for determining the
16 limits imposed by his or her retirement plan on hours worked or income received
17 and for ensuring that the total amount of work performed does not compromise his
18 or her retirement benefits.

20 (b) Retired bargaining unit faculty members whose last pre-retirement FTE on record
21 is .50 or greater may enroll in classes up to the maximum number of credit hours
22 (space permitting). If the class is taken for credit, the bargaining unit faculty
23 member will be charged the discounted staff tuition rate. Retired bargaining unit
24 faculty may audit a class at no charge on a space-available basis with the
25 instructor’s permission. These benefits do not extend to family members of retired
26 bargaining unit faculty members.

28 (c) Retired bargaining unit faculty members receive a staff discount rate on season
29 tickets for all sports.

31 (d) Retired bargaining unit faculty members may join the ERB Memorial Union Craft
32 Center at staff rates.

34 (e) Retired bargaining unit faculty members will receive a UO ID card and a
35 University of Oregon email account (subject to the provisions of this Agreement
36 for use of an Oregon email account), and may also request access to the
37 university's network. The retired faculty members’ last department of affiliation
38 may request that the retiree be granted access to Active Directory and Exchange.

40 (f) Retired bargaining unit faculty members are granted the same access to UO library
41 resources as active faculty.

43 (g) Retired bargaining unit faculty members are eligible to receive one parking permit
44 at no cost during terms when the retired faculty member is not on the university
45 payroll, as long as the retired faculty member provides a signed statement from
46 his or her department head identifying the meaningful contribution to the
47 university made by the retired faculty member. Examples of meaningful
48 contributions may include volunteer work at the university, participating in
49 university events, and course enrollment.

- 1 (h) Retired bargaining unit faculty members may join the Student Recreation
- 2 Center (SRC) at a reduced membership rate.
